ED notices to SRK, Gauri Khan

Actor, wife asked to participate in adjudication proceedings on Rs 73.6-cr forex loss caused due to transfer of Knight Riders Sports shares to Mauritius firm

THE ADJUDICATING authority of the Enforcement Directorate (ED) has issued notices to actor Shah Rukh Khan and his wife Gauri Khan, who is a director of Knight Riders Sports Pvt Ltd (KRSP), to participate in the adjudication proceedings scheduled on August 23 in a case of alleged violation of Foreign Exchange Management Act (FEMA). KRSPIL owns the Kolkata Knight Riders team of the Indian Premier League (IPL).

The adjudication proceedings pertain to alleged loss of Rs 73.6 crore foreign exchange caused due to the transfer of KRSPIL shares. In March, the ED had issued showcause notices to KRSPIL's director Gauri, and KRSP team owners Shah Rukh and Juhi Chawla. The notice had been issued for the sale of shares of KRSPIL to a Mauritius-based firm at a cost lower than their 'actual value', resulting in loss of foreign

exchange to the extent of Rs 73.6 crore. The agency said the notice had been issued for "contravention of provisions of the Foreign Exchange Management (Transfer or Issue of Security by a Person Resident Outside India) Regulations, 2000 made under the Foreign Exchange Management Act".

The case dates back to 2008-09 when the ED first began investigation against the IPL franchise

and its owners. Khan and the others have been questioned by the ED multiple times in this case and the actor's statement was also recorded under FEMA provisions.

Khan's company Red Chillies Enterprises Private Limited (RCEPL), the agency said, was a wholly-owned subsidiary of Red Chillies International Limited based in Mumbai and is co-owned by Gauri.

In 2008, RCEPL formed a spe-

cial purpose vehicle namely M/s Knight Riders Sports Ltd for the purpose of acquiring IPL franchise rights of Kolkata Knight Riders.

Initially, the entire shareholding of KRSP Pvt Ltd was with Red Chillies Enterprises and Gauri Khan. Subsequent to the success of IPL, the ED said, KRSPIL issued about 2 crore additional shares. Of these, 50 lakh shares were allotted to The Sea Island Investment Ltd. (TSIIL) in Mauritius and another 40 lakh shares were issued to Chawla.

These shares, according to the ED, were allotted at a par value of Rs 10 a piece, whereas the actual value of these shares was much higher. Juhi Chawla subsequently sold her 40 lakh shares to TSIIL. Mauritius at the par value of Rs 10 only. Thus, foreign-based company TSIIL was issued 90 lakh shares at par value while the actual cost of share at the time of issue/sale was ranging between Rs 86 and Rs 98 per share. This has resulted in loss of foreign exchange to the extent of Rs 73.6 crore," the ED had said.

Shahapur farmers protest against land acquisition

DESPITE CLAIMS by the Maharashtra State Road Development Corporation (MSRDC) officials that all farmers in Shahapur taluka have given their consent to land acquisition proceedings for the Maharashtra Samruddhi Corridor, a group of farmers trooped in to the tehsildar's office in a 'jail bhandan' on Thursday. The officials have begun to believe that we have consented to land acquisition for the project. We had to show them that we are still mad against the land acquisition as before. If they have received consent, then who are these farmers?" asked Baban Harne, a farmer activist from Shahapur.

shortly after. Of the 700-km Maharashtra Samruddhi Corridor from Nagpur to Mumbai, a stretch of 54 km passes through Shahapur taluka in Thane district. The farmers here have been protesting the impending acquisition of their land and have held several protests. However, three farmers from Shahapur handed over their land for the project on Saturday, at a ceremony attended by PWD Minister Ek Nath Shinde of the Shiv Sena.

"Of the three farmers who handed over their land, two are connected with political parties," claimed Harne. "Instead of making these false claims, they should hold discussions with the farmers to know their perspective."

According to MSRDC they have received consent from all affected farmers in Shahapur taluka.

Meanwhile, MSRDC began the land purchase for the project in Jaha and Lonar on Thursday. The farmers in these areas handed over their land in the presence of PWD minister Shinde and immediately received compensation from the state agency through RTGS.

Around 300 farmers from the taluka marched from the local jail stand to the tehsildar's office and submitted a list of demands. They then moved to the police station to get themselves arrested. They were detained and released

ONLINE MEDICINE

HC informed about Centre decision to set up e-portal

Mumbai: The Bombay High Court was on Thursday informed that the Union government has decided to set up an e-portal where manufacturers, distributors, chemists and retailers will have to register if they want to sell medicines online. The decision has been taken to regulate online sale of medicines. A division bench of Chief Justice Manjula Chellur and Justice N M Jandara was hearing a PIL filed by city resident M Patil highlighting the issue of medicines being easily available online and students buying drugs based on false prescriptions.

Additional government pleader P P Kakade submitted a public notice issued by the Union Ministry of Health and Family Welfare. The HC had taken serious note of the matter and asked the government what steps it proposed to take to tackle the issue. ENS

"The objective of such regulation would be to ensure availability of right drugs that meet the standard of quality to every person, in need of medicines, curbing anti-microbial resistance and also regulating supply of medicines online or on internet to persons or other entities outside India," the notice said. "The government proposes to establish a robust e-enabled structure for regulating sale of medicines. An electronic platform will be developed and maintained by an autonomous body under the Ministry of Health and Family Welfare," the notice said. TISS to offer 4-credit Secular Ethics subject

Nearly 30 vice-chancellors have been invited for the first lecture

TATA INSTITUTE of Social Sciences (TISS) will now offer a four-credit Secular Ethics subject to inculcate 'empathy' among students. The new course will be inaugurated on August 14 with a lecture by His Holiness the Dalai Lama, said director S Parasuraman.

Other lectures will be delivered by Buddhist and Sanskrit Scholars, the director told The Indian Express. "This is not a religious course, but a spiritual one. The course will include yoga and meditation. Lectures will constitute only 30 hours of a semester. The students will have to engage in 60 hours of field work where they pass on their knowledge to the society," he said.

"The subject will teach students how to relate to fellow beings, listen to people. The first

lecture will be delivered by the Dalai Lama," he said.

While 500 students of the institute will form the first batch of the course, nearly 30 vice-chancellors have been invited for the first lecture. "We want to extend the course to educational institutes across the country. We have invited vice-chancellors of universities, principals of colleges and schools for the lectures. It will also be extended to MPs, MLAs. The aim is to take the course forward to many institutes in the country as possible," said Parasuraman.

The subject will carry the weightage of four credits. Lectures will be made available in the digital format for other institutes to use in the form of massive open online courses. Earlier, first-year students of the institute were informed of the course during the orientation programme. They said they were looking forward to the lecture by Dalai Lama.

Mumbai youth drowns in lake near Lonavala

A 24-YEAR-OLD youth from Mumbai died after drowning in the Ghubad Lake near Lonavala, after he lost his balance and slipped on a rock under a local waterfall on Thursday morning. This is the second death of a tourist near Lonavala in a week.

The deceased has been identified as Dhawal Vijaybhau Parmar, a resident of Andheri, who had come to the hill station with his friends for a picnic. At 9:30 am, Parmar and his friends went to Lion's Point, located 10 kilometres from Lonavala town, and then to Ghubad Lake. An officer from the Lonavala town police station said, "As per our preliminary information, Parmar started

climbing a rock under the waterfall and slipped. He fell into the water and could not swim as he had sustained injuries. His body was later pulled out of the water. A few days ago, a 23-year-old youth from Hadapsar, who was visiting Bhushi dam with his friends, died after he fell down while climbing a rock near waterfall. The police officer said, "Many of our staff are deployed at these locations to manage the flow of tourists and to warn them against climbing the rocks as they are extremely slippery. Also, when it rains, the flow of water at these falls can suddenly increase... These areas receive very heavy rainfall and a sudden increase in water flow can be dangerous anywhere. But tourists never listen and (advocate) times, even argue with us..."
